1. Personally-Identifying Information

3. Protection of Certain Personally-Identifying Information

E-Wills discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organisations that (i) need to know that information in order to process it on E-Wills's behalf or to provide services available at E-Wills's website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside of your home country; by using E-Wills's website, you consent to the transfer of such information to them. E-Wills will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organisations, as described above, E-Wills discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when E-Wills believes in good faith that disclosure is reasonably necessary to protect the property or rights of E-Wills, third parties or the public at large.

If you are a registered user of <https://ewills.eu> and have supplied your email address, E-Wills may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with E-Wills and our products. We primarily use our blog to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. E-Wills takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.
